Everything we do at TROX Auranor takes protection and responsibility into account. We are extremely aware that our operations have environmental and social impacts far beyond the actual company.

As market leader we impose stringent demands towards ourselves, and actively work with improvement measures. With locally-made products, a global perspective and a conscious approach to conserving nature, TROX Auranor takes responsibility for creating a good indoor climate for people with a concern for the environment and sustainability. We see that environmental protection and economic and social development interact and mutually reinforce one another. Our factory and head office at Brandbu are located in a rural area with the forest and its bio-diversity as our nearest neighbour.

OUR ENVIRONMENTAL POLICY

At TROX Auranor we continuously work to be a driving force in our industry. One of the key targets for 2018 was to achieve Eco-Lighthouse certification, and we received the certificate on 27 March

Together, TROX Auranor's management and employees shall create a good working environment and positive attitudes related to HSE work. Our most important resource is our employees. HSE work is governed by official regulations and the company's own Health, Safety and Environment policy. We shall continuously work with well-being activities and measures to prevent absence due to illness, injuries, fire and accidents. Our business must strive to reduce environmental impacts beyond official requirements. We seek sustainable and innovative solutions in the entire added value chain. TROX Auranor works to create a good indoor climate for people, with a concern for the environment.

Other key targets include reducing energy consumption, the amount of waste and number of flights. We are dedicated to imparting basic environmental knowledge to our own employees, and have established an Environmental Group which plans, implements and evaluates information and necessary measures to raise the awareness of each individual with regard to what they may contribute to reduce environmental impacts.

RAW MATERIALS AND WASTE

There is a high proportion of recycled matter in our raw materials: aluminium, 30% recycled material; aluminium profiles, 35% recycled material; steel, 25-100%; and insulation, up to 70% recycled glass in production. Other components of the products, such as paint and sealants, are classified as non-hazardous according to Regulation (EC) No 1272/2008 (CLP). TROX Auranor manages its own waste, and sorting at source is part of our everyday routine. We sort into 17 fractions, and aim to increase the number of fractions further in our action plan. We take responsibility for the environment through our Eco-Ligthouse certification and membership in Green Dot Norway and Renas.

PROCUREMENT/SUPPLIERS

Our key suppliers have signed our Code of Conduct, which includes rules and guidelines for the treatment of employees and the environment. Here we have zero tolerance for forced labour and child labour. We constantly work on improvement measures with our suppliers with regard to freedom of association, equal rights and fair and statutory income, fixed working hours, a safe working environment, legally binding employment relationships, as well as requirements that all commitments, statutes and rules concerning social security should be respected. We encourage our suppliers to achieve environmental certification, just as our customers demand this of us.

ENERGY CONSUMPTION

TROX Auranor has an express goal of saving energy and provides clear guidelines to the suppliers of the most energy-demanding production machines in the investment phase. In terms of buildings we also have good procedures for what must be closed/downscaled during holidays and outside of the heating season, as well as service agreements for technical facilities. We work according to long-term plans for energy-saving measures.

EMISSIONS TO AIR, GROUND AND WATER

Our production produces little pollution, and we have good safety procedures to ensure that the environment is not impacted by our activities. Our policy with regard to business travel and company cars includes guidelines to use online meetings whenever possible and more emission-friendly vehicles as new technology emerges.

AESTHETICS

The company has established standards for work areas, floor marking, colour use on machinery, labelling and signage. This also concerns the safety of employees and visitors.

TROX Auranor is concerned with maintaining rural areas. A large proportion of our staff come from the immediate area, and we take care to use local businesses to supply goods and services to the extent this is possible.

We also make donations and contribute sponsorship to local associations and clubs, thus supporting both our employees and their families and the local community as a whole.

WORKING ENVIRONMENT

As expressed in our Environmental Policy, together, TROX Auranor's management and employees shall create a good working environment and positive attitudes relating to HSE work.

We also have an occupational health service, staff association and company sports team. We conduct annual appraisal interviews, and employee satisfaction surveys are carried out every two years.

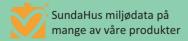
